In view of the above position, the Board recommends for grant of permission for the functioning for conducting UG (BHMS) course with 100 seats M.D. (Hom.) Course in subjects Organon of medicine-06, Materia medica-5, Practice of Medicine-3, Repertory-3 for the academic year 2022-23, under NCH Act, 2020 and its relevant regulations.

3. All admissions in Under Graduate course shall be through NEET/AIAPGET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by DBHP'S Dr. B. D. Jatti Long in the state of the remaining 85% seats or as the case may be, shall be conducted by the DHARWAD.

The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules. The College has to comply with the full requirements as per NCH Act, 2020 for conducting the course.
